You have the right to retain and instruct counsel. Correction of certain motor vehicle
offences will result in a record being placed against your driving record. If you
fail to respond to this Offence Notice as required by law by the court appearance date
indicated above, or if you plead not guilty and fail to appear in court in person or by
an agent on your trial date, you will be deemed to dispute the charge and you may
be convicted of the offence in your absence without a hearing.

If you are convicted, until the fine plus any late payment charges are paid in full,
you will not be allowed to obtain or renew your motor vehicle registration and/or
driver's license and other civil collection actions may be taken against you to
collect the amount owing.
