Re: High Priority

Trespass [Malfeasance, Obstruction, Extortion]

Trespass on the Case [CV-20-00002184 & CV 20-00003546]

Greetings Thomas and Stephen,

This communications is high priority requiring attention due to corruption at Milton public courthouse;

i, require produced immediately the law or evidence 'Rules of Civil Procedure' apply to we the people;

Two common law courts CV-20-00002184 & CV 20-00003546 are trespassed [Barratry] upon;

Multiple people [BAR members] and staff trespass at Milton Courthouse obstructing access without right to move claim and court outside of the BAR who's private 'rules' do not apply to we the people; Milton Courthouse is a PUBLIC building...not PRIVATE for BAR members to access exclusively;

This claim [not complaint] of trespass is verified as NO evidence as required produced in 8 months;

Claims filed and court established September 12, 2020 & December 22, 2020 a right of we the people;

First claim filed involves 10 people [2 act as Justices/public servants] and 8 act as lawyers for BAR;

Claim and court established to address these people who trespass [administrate property without right];

This action was filed when NO evidence produced 'rules of civil procedure' apply to a [wo]man;

Notice was given 3 times to all produce evidence... all acquiesced...our claim on 'rules' stands true;

No [wo]man acting at Milton Courthouse with duties and obligations trump a right to access justice;

FACT Milton Courthouse is a public building and NO [wo]man within can deny, block access or pass judgment until a jury of our peers is seated ... the jury will decide [rule] if our claims be true or not;

Not people who act for service corporations wearing black robes whose duty is move process forward;

A sacred right to access public courthouse includes good faith services provided by people involved;

This began Sept 29<sup>th</sup> 2020 Deborah [woman acting as Registrar] allowing BAR members to trespass;

Then Kendra Coats a woman who acts as a Justice 1<sup>st</sup> trespass Wed 10/28/2020 10:07 AM by way of an 'Endorsement of Madam Justice Coats' to rule on our filing not moving under rules of civil procedure;

This trespass again was addressed in writing to registrar and Kendra who did not produce evidence said rules Kendra wished to apply to we the people to access/move claim and court before our peers;

Honorably this was taken up the chain to the top people acting as Chief Justice of Ontario and Canada;

Again 3 verified communications sent unanswered ...all acquiesced due to no evidence exists that said 'rules of civil procedure' apply to we the people or our property filed at public courthouse;

Registrar and Kendra did not move process forward as required after months communicating so Dec 22 2020 2<sup>nd</sup> claim filed to address these people [bar members] shielding other Bar members from verified trespass occurring causing enormous wrong or harm.

Kendra was now part of this 2<sup>nd</sup> claim filed along with Deborah [registrar] for their obstruction. Due to Christmas holidays and current covid nonsense process server delayed/succeeded Jan 18<sup>th</sup> @ 3:35pm;

Kendra retaliates with vexatious Jan 21<sup>st</sup> 2021Citation [Exhibit 3] using again 'rules of civil procedure' to justify trespass remove our property [claim] with further threats of extortion to pay people who act as lawyers...also without standing in 'Sekulovski Court' and all due to Kendra creating documentation converting our common law jurisdiction into a legal jurisdiction which she then would have control;

This is completely unacceptable and a breach of trust and obligations to provide to we the people;

Now our 2<sup>nd</sup> filing of December 22, 2020 is trespassed upon by another [wo]man/public servant/bar member F.L Myers who acts as a Judge and does trespass [endorsement] Dated 2021 02 05 [Exhibit 4]

This is very serious Thomas and Stephen the required evidence has NOT been produced EVER that the 'rules of civil procedure' created by a private society for THEIR society applies to common law jurisdiction which the 'Sekulovski Court' was established and moving under;

The only way these people can administrate our property is with our consent or obligation produced;

Or if these people claim we are property which we the people clearly understand is not true;

This corruption is now out in the open on the public record for months showing the public what is occurring and required action to stop this trespass now and restore our property move process forward;

This is an unalienable right for people to seek the administration of justice and not to be denied by our fellow man who are acting as public servants with enormous responsibility and trust placed upon them to insure no trespass occurs until it is brought before a jury of our peers [trial by jury] and they decide.

In the event as these people have slanderously written our claims against their fellow BAR members are not true and without merit then the jury of our peers will see this and hold us fully liable;

What we have here is a group of people who believe they can block/judge our claims that are against their fellow BAR members and remove our property [verified claims] from said public courthouse;

They cannot... and the law is required produced post haste by Thomas or Stephen if not be true;

Failure to produce this required evidence... these people must be addressed and our property restored;

This is a VERIFIED trespass by people [acting as Justices/public servants] at courthouse without right cause massive wrong and harm further with vexatious and repugnant acts of Barratry hiding corruption;

This has gone right up to the top people acting for service corporations [ONTARIO, CANADA ECT]

The evidence foundational to our claims stands true and we require your assistance to stop trespass;
