i, attach again the final communications to both Kendra Coats and Fred Myers who trespassed;  
This communications is high priority requiring attention due to corruption at Milton public courthouse;  
i, require produced immediately the law or evidence 'Rules of Civil Procedure' apply to we the people;  
Two common law courts CV-20-00002184 & CV 20-00003546 are now compromised [trespassed];
