**NOTICE: LIABILITY** 

Good Day Mark and Naheed,

This notice is to the man Mark who sometimes acts as Chief of 'Calgary Police Service' and to the man Naheed who sometimes acts as 'Mayor' for a SERVICE Corporation' Calgary';

Trespass occurred Saturday December 26<sup>th</sup> 2020 @ 11:40am by people under Mark and Naheed control;

A man acting as 'Staff Sergeant of Calgary Police Service' badge #2737 trespass without right [Exhibit A];

Two additional people [names unknown] also agents of 'Calgary Police Service' trespass without right;

i, do not accept or consent to such a disgusting attempt to contract [Exhibit A] by agents under your control;

### i, demand post haste Mark and Naheed produce written verifiable evidence with wet signature that...

- 1. Mark or Naheed or any man or woman under your control claim i... property;
- 2. Mark or Naheed or any man or woman under your control can administrate property without right;
- 3. Obligation [contract] produced either service corporation has for jurisdiction [control] over i;
- 4. Produce the verified claim from another man or woman i, trespass cause wrong or harm;

Failure to produce evidence required as stated above... withdraw verified trespass [exhibit A];

Otherwise Mark and Naheed are liable and i wish to forgive and resolve trespass without conflict;

i...honorably return offer to contract [Exhibit A] and further give 'Notice: Liability' do not trespass again;

Trespass fee: \$100,000 for Mark and Naheed per agent/officer under your control who trespass;

Trespass fines are in place as of today, govern yourselves accordingly ignorance will not be tolerated;

Any orders given let it be known my fee is \$1 per second to comply where no contract exists prior;
