i, do not know a man named Gavin Hoekstra nor is a verified claim of trespass within said documents;

i...require produce post haste written verifiable proof a verified claim exists or...

1. i, property of Gavin or any man or woman of the bar
2. any contract exists with Gavin or LAW SOCIETY OF BRITISH COLUMBIA

Failure to meet said basic in Law ...this communication is baseless, frivolous and a vexatious trespass;
