Greetings Myron, Falguni, Olivia, Wendy, Doug and Doug...

i...a man claim trespass [Exhibit #1] by multiple people acting under your direct control/service corporations;

Trespass by a man acting officer #13156 Platoon CRU Unit 52 on August 18th, 2026 under Myron control;
Trespass by a man acting officer# 12052 Platoon C Unit 52 on August 18th 2026 under Myron control;

i...was not operating under any license at time of trespass but exercising my right to travel freely;
