Notice Tacit Agreement / Trespass Fines

Greetings Myron, Falguni, Olivia, Wendy, Doug and Doug...

i:man:Mark of the Theodoru family claim/verified trespass did/does occur as of September 17th 2026;

All people noticed did not answer/produce required evidence to jurisdiction (contract/trespass claim) exists;

Your offer[s] [Exhibits] to contract including disclosure i returned i do not accept or consent on public record

i, did/do not consent to this trespass without right is also again on public record;

Any legal action[s] will be your willful agreement to Trespass Fines contract with i without jurisdiction;

i... nor any [wo]man tolerate constructive fraud at public courthouse or ignorance of law...not policy:

i, attach all prior ‘Notice’ communications unanswered addressing presumed jurisdiction honorably;

All named especially acting Attorney-General are responsible for this corruption occurring by all involved;

All people involved have willfully acquiesced which is now on the public record;

A tacit agreement is established also on the public record verified and established trespass did/does occur;

Correct the record and stop trespassing immediately as this cause wrong and harm to i;

All named and any other [wo]man who trespass will be held liable if trespass not stopped;

i, wish to forgive said trespass and be left alone to live in peace as is my God given rights which are supreme;

i, will not appear in any legal 'person' capacity only as a man by special appearance noticed honorably to all;

Further my **Tresspass fines will be activated by your actions** if actions continue force a court appearance;

Trespass Fines are given and now on the public record are as follows...

1. \$ 200,000 per [wo]man involved on the private side

2. \$ 1,000,000 per [wo]man involved on corporate side acting as agent for service corporation[s];

i, require in writing withdrawal of all trespasses [offence tickets] by way of ignorance and constructive fraud;

Every [wo]man involved has a duty to provide good faith services to the people...not fraud and malfeasance;

Notice Tacit Agreement package sent registered mail to all as named again on this communication;

Govern yourselves accordingly as i...acted lawfully/honorably the whole-time on verified trespass occurred;
