



Thank you for your response. I had sent you the document through a secure platform using Citrix Sharefile which provides an extra layer of encryption. Instructions on How to create a Citrix ShareFile account

1. There will be two emails from Citrix server, one is to activate the ShareFile account and second email to access encrypted message.
2. To activate user account, click on the link provided in email to create account.
3. Enter First Name and Last Name, Company name is optional. Click Continue.
4. Create password with mentioned requirements and click "Save and Sign In."
5. Once the account is created you will be able to access encrypted messages or attachments sent via Citrix ShareFile.
6. The Sender will get an email notification when the encrypted message is viewed by the receiver.

Consent and Release for Email Communication

If you would like to receive email communication from Peel CAS, then you must ensure that your contacts/address book is updated to include Peel CAS employees with whom you usually work. If your contacts/address book is not updated, then please check your junk or spam folder.

Please review all of the information in this consent and release for email before signing the consent.

Limitations to Email Communication

Even though you have shared consent to receive emails from Peel CAS, there are still some limitations on what and when we can email you information including:

- **EMERGENCIES** - email should never be used in an emergency. If there is an emergency, 9-1-1 should be called and/or call the Peel CAS after-hours service available 24 hours a day and 7 days a week at 905-363-6131.
- **URGENCY** – email should never be used to share urgent issues or concerns, where you need a response from Peel CAS by a certain time. If you have an urgent issue, you should call the worker or Team Lead to share the issue or concern and/or set up an in-person appointment.

- **AFTER HOURS, HOLIDAYS OR WEEKENDS** – email is not monitored after business or when our offices are closed. If you require an immediate response to an email message you have sent, then please call us and speak to someone directly.
- **COMPLEX or SENSITIVE INFORMATION** - email should only be used to share information that is to the point and short in length such as scheduling appointments. Due to the inherent risks associated with email communication, if you have information to share that is more complex or sensitive in nature, then please call us instead.

Risks with Email Communication

There are some potential risks to your privacy when communicating by email:
