On Saturday, November 2, 2019 I was approached by a woman named Parmjit Deol who got my name from Jotvinder Sodhi.

She explained her current situation and that there was an issue before the courts regarding custody of her and her ex-husbands seven year old daughter. She was concerned and was experiencing stress because of the situation.

I offered to meet her the following day and help her unburden some of her emotions surrounding her concerns.

She agreed and when they arrived the following day, I placed the daughter in a separate area away from us while I was speaking with her mother, and Sharan kept watching us, so I asked her if she wanted to join us.

In the process of speaking with Parmjit, Sharan started to speak to me about what was happening when she was with her father. At that time I decided to record what she was saying, and what she said was quite disturbing, I felt a need to report it.

I am sending you two emails. One including Jotvinder Sodhi's contact information as he was the one who sent the mother to me. That email will not have the recording attached to it. This email excludes him as it has a copy of the recording attached. I am separating these emails to ensure Sharan's privacy.
