This is to notify you that I submitted a report to Peel CAS on Thursday, November 21, 2019. From what I understand, Judge Sullivan is not privy to this information.

My report includes a recording I made of Sharan Dhanjal-Deol speaking about abuse she was experiencing. My understanding is that CAS has not notified you of this report and even though it involves the well being of the daughter named above. To date (November 25th at 4:38 pm) CAS have not contacted me to clarify further the report I submitted.

As my email and the recording have been forwarded to counsel for the husband, it seems everyone is in the know except Judge Sullivan.

I am writing this as official notice that they are intentionally holding back information involving the decision you are making tomorrow.

I have only met Parmjit Deol twice, I have no vested interest in this other than to do the right thing. [PEDOGATE: Women Operatives In Very High Places – The Millennium Report](#)

Carolyn Mulroney's mother is named as one of the high profile female pedophiles and her daughter Carolyn Mulroney as the AG of Ontario recently took independent oversight away from CAS. As this is all coming to light, we have to ask about the integrity and motivation of Peel CAS workers.

Either way the truth is coming out. If the people in the system cannot be honest, we do not have a system that works for the people. It is that simple.

Laureen Harper is also named as a high profile female sex offender listed above, and she sits on the board of directors at the Calgary Children's Advocacy Centre. This cannot be a co-incidence.

As Gia Williams has said they will contact me and has yet to do so, can we start asking about the level of integrity she operates with? What could her motives be to lie? It is estimated that 70% of children who are human trafficked for the purpose of sex have had experiences with CAS. The public is catching on.

Do what you will with this. The people who work in the system can no longer say they don't know that pedophiles are in charge. This bears closer scrutiny.

The behaviour of Peel CAS is not acceptable.
