ACCUSED: Thank you, I decline your offer and preserve my right to deal with the matter where I stand.

HER HONOUR: Sir, if you choose, as long as you can hear clearly. Who's running this matter today?

25 PROSECUTOR: I appear in this matter, your Honour.

HER HONOUR: Thank you there, Ms Tomasetti. Mr Leyshon, do you maintain your plea of not guilty?

ACCUSED: I make no plea to this to this Court. I'm a living man here by special appearance only..(not transcribable)..

HER HONOUR: Sir, sir, can you just answer--

- ACCUSED: ..(Not transcribable)..to deny jurisdiction to this Court. For the record, I'm not a name, nor am I legal person. I reserve all rights and waive all benefits and privileges.
- HER HONOUR: All right. Thanks there. Take a seat if you like or stand up if you choose. I'll note on the papers that in the absence of any meaningful reply by Mr Leyshon I've marked the papers as he continues his plea of not guilty. This is an event--
- ACCUSED: Objection, your Honour. Are you, are you practising from the bench?

HER HONOUR: --31 August 2021.

ACCUSED: Second time. Ms Stapleton, are you practising from the bench?

HER HONOUR: Sir, you can call me your Honour and--

ACCUSED: Third time. Ms Stapleton, are you practising from the bench?
