

My name is Christopher [REDACTED] and my contact surrounds a very serious Trespass beginning in 2018 involving multiple agents now under your control against [REDACTED]

My professional background is extensive focusing on investigations [fraud, corruption] with a background in law. Having worked with all levels of law enforcement over the past 20 years it has provided a unique position to deal with serious matters such as this and of such magnitude with honor.

i, realize Rod your acquiring the portfolio for the MOF recently takes some time to get up to speed and yet this matter requires your direct attention now for us to quickly get facts on the table and resolve.

i, have stated to [REDACTED] and family that the MOF has thousands of communications a day and Rod or the man prior Vic cannot know every single matter given enormous day to day communications received.

i, am reaching out to Rod because i believe you don't wish wrong or harm to come to another man or woman ever... and yet this is exactly what has and continues to occur which must stop immediately.

i, was asked a week ago by [REDACTED] to review MOF communications and actions over past several months.

After my review...i, am at a loss to understand HOW this matter elevated to such a level when [REDACTED] and family have honorably acted/worked to address ALL agents of the service corporation ONTARIO.

[REDACTED] have been treated as if they are common criminals running guns or child trafficking while operating a small family vegetable farm exporting tobacco [exhibit#2] without ANY problems.

[REDACTED] have been farming in Ontario for over 30 years without trespass while raising a family and living in peace with their fellow man. They are lawful people who take pride and care in everything they have built successfully for their family farming business. "ALL" Crown Service Corporations agents duties & obligations ARE to SERVE and PROTECT the property of man NOT steal it.

In 2018 agents of the Ministry of Finance trespassed without right multiple times causing wrong [financial] backing the family into a corner under severe duress to this day[exhibit #3] without right.

Only your direct attention at this time will insure we can settle/correct this honorably without the need of prosecutions against all to correct crown agents actions insuring this never happens again to people.

██████████ communicated May 29<sup>th</sup> 2019 honorably and detailed giving NOTICE to all involved as best he could but the timeline during this communication was during Vic transition with Rod taking over. Brent received no response which has now led to this contact to get this on table face to face and correct.

██████████ have been misled/misrepresented by BAR members to date and at a public courthouse.

Thomas Carrique the man who acts as OPP Commissioner has been copied/given notice/claim of this horrific trespass is now on public record. We have 11 people [exhibit #1] causing wrong & harm to date.

Doug Downey the man now acting as AG for service corporation ONTARIO is copied/given notice.

This should not take more than 15 minutes to address. Given what has occurred to date ██████████ and i, require a sit down with Rod [who is also one of the people] to insure we resolve this swiftly now for all.

All of us are better than what has occurred here Rod... there is no room for this type of tyrannical draconian acts against the people which i, am confident once we review together the few documents will quickly reveal ██████████ have caused no wrong or harm and resolve this trespass.

The trespass against ██████████ is nothing shy of vexatious and without merit by multiple people.

Several unlawful acts/claims made by agents under Rod control comes down to a few simple questions:

1. Who within the service corporation ONTARIO can administrate a [wo]man property without right?
2. Where's the bill of particulars [damages or loss ██████████ caused by their actions]
