Christopher name was given to me by others under attack in our rural communities;

Christopher was contacted in Aug 2019 and involved as Prosecutor 'counsellor at law';

Christopher stepped in to protect us via court prosecutions moving under common law;

i, attach the verified court filing [prosecution] Court File No: CV-19-00000081-0000;

i, claim on Oct 30<sup>th</sup> 2018 and Nov 2<sup>nd</sup> 2018 trespass [theft] see Court file Exhibit #3;

Top people at 'Ministry of Finance' & 'Attorney General Office' of Ontario involved;

Thomas W.B. Carrique [OPP Commissioner] & people under his control also involved;

OPP provide support to the MOF and AG and further are in direct 'conflict of interest';  
Conflict of interest with verified terrorism against my family requires RCMP step in;  
This is much more serious than Cathy is now aware and why meeting required ASAP;  
Christopher will attend as he has put his life at risk with what we have now been shown;  
We will bring with us the video evidence foundational to prosecutions commenced;  
When property was stolen a phone call came shortly after 'the mob has it' and hung up;  
The number was unlisted but we have the date which could be traced;  
This contact is also backed by what 'Brad Blair' past OPP commissioner has claimed;  
There is vast corruption occurring within the service corporation ONTARIO;  
Brad has lost faith in the OPP Organization because it has now been compromised;  
Brad stated with lawyer much more on the public record Sept 14 2019 requiring action;
