Greetings Cathy,

First,

Our initial contact to RCMP surrounding said trespasses was October 16th 2019;

We have now communicated 5 times to the RCMP and have received NO contact;

Let this be CRYSTAL CLEAR to understand the basics requiring RCMP take action;

1. i, and my family have farmed [produced] for 30 years NEVER have had a problem;
2. Oct 28th & Nov 2nd 2018 we had 2 loads [2/3rds entire tobacco harvest] stolen;
3. Our property [Leaf Tobacco in small boxes] Quebec Police stole from MOF ph call;
4. Dec 31st 2018... i, no longer hold tobacco license, **quit growing Tobacco in 2019**;
5. Jan 1st 2019 i, and  **100% out of Raw Leaf Program**;
6. Agents [MOF] harass us March & May 2019 and Sept 12 2019 [3 OPP cruisers];
7. All trespasses agents demand access to property without right/obligation or warrant;

This is no different if MOF and OPP show up at Cathy's farm [property] demanding accesses when Cathy IS NOT part of ANY 'Raw Leaf Tobacco Program'... they can't use intimidation/force as occurred in order to gain access when the people [property owners] have NOTHING to do with MOF or their services programs and fine them?

It's no different if McDonalds or Burger King or Ford Motor Company agents all demanded access to our property to inspect inside and outside of our property... they [agents] have no right to show up or make such demands and neither does/did the MOF unless contract [signed] by [REDACTED] exists or warrant/bond produced;

It's this simple... the RCMP MUST ACT NOW...STOP THESE PEOPLE NOW!

[REDACTED] will be bankrupt by March 2020 due to the original theft and now with further fines of \$1.5 Million.... ALL OFFENCES IN 2019!!!

The [REDACTED] Court' established is the lawful remedy and would have STOPPED all of this corruption had it not been removed without right by Lynda C. Templeton.

This corruption is vast and in 3 parts now simply for RCMP to address not sit and continue to do nothing. First is the theft property [2018 harvest]... 2nd is trespassing with intent/attacking family on site and by way of intimidation and extortion throughout 2019 by MOF agents and then with OPP... and 3rd.. [REDACTED] property [verified 'court filing' also sworn under oath/on public record with JP was unlawfully removed from a public courthouse without the Registrar's knowledge.

As of today [REDACTED] is blocked as ORDERED by Lynda C. Templeton [see below] to refuse ANY of [REDACTED] paperwork or filings. He is being denied a RIGHT at a PUBLIC courthouse by people who have NO RIGHTS but duties and obligations to operate the public courthouses not obstructing people who have a right to access a public courthouse and move their claim and court outside of a LEGAL society to which they do not belong....as the lie 'rules of civil procedure' apply to we the people is exposed;

As of today NO ONE...not Lynda C Templeton [Top Regional Justice], Thomas Carrique [OPP], Doug Downey [AG] and staff, Administration staff at St. Thomas Superior Court of Justice, Geoffrey B. Morawetz [Acting as Chief Justice of Ontario], Cheri Emerich [JP] or Cathy McCrory/intake....have produced the Public law in writing as required that states 'we the people are bound to 'Rules of civil procedure';

The required FACT [law] has not been produced...it's over 3 weeks RCMP must act; If has NOT been produced [and it won't be] so RCMP duty is to restore [REDACTED] Court' Court File: CV 19-00000081 posthaste as RCMP is now causing wrong and harm by doing nothing since Oct 16th 2019 as all of this corruption and lies are front and center;

Once [REDACTED] Court' is restored all of this corruption will stop with accountability;

It has already been established the St. Thomas Superior Courthouse is PUBLIC;

It is now FACT....Lynda took [REDACTED] property without right and administrated [obstructed, removed from courthouse] over it knowing full well she has no jurisdiction;

RCMP officers we require to accompany [REDACTED] to courthouse and see filing is restored;

Secondly, [NEW INFO]

Quebec court actions underway fall 2019 /we addressed/corrected Dec 3rd 2019;

It has now been brought to my attention the trucks before they leave farm/signed off on are sealed with a sticker. This has been done from day one for years but on Oct 28th 2018 the MOF agent refused to put a seal and said "I don't have to if I don't want to" [witnessed by no less than 4 people] and guess which load was pulled over first? Well the one with no seal/sticker in Quebec...how convenient...the intent is clearly exposed;

A woman acting as Attorney General [Isabel Deschamps] out of Quebec acknowledged seal[s] broken without federal order/carried out by the RCMP [learned Dec 3rd 2019];

WHY NO STICKER? Never had this been done prior on ANY [REDACTED] farm load;

It's obvious as all evidence shown to RCMP this was a 'set up' by MOF agents;

The 2nd trailer taken on Nov 2 2018 had the FEDERAL GOVERNMENT export seal on it...and we have learned further that this seal was broken... appears by the local police;

Thursday, December 05, 2019 Isabelle Deschamps revealed that, 'possibly she was wrong and possibly the POLICE are wrong after she received our response/evidence;

Isabel had filed court actions against [REDACTED] [a trust not the man] seeking \$1M in damages on October 30th 2019 then withdrew her filing telling us to 'disregard';

It appears truck drivers are now getting their property [trailers] back [held over a year];

Thirdly,

We have multiple farmers now coming forward who have also been given massive fines for doing nothing wrong. [REDACTED] .. 21 year tobacco farmer NEVER one problem... then in 2018 MOF agent on his farm during load states "hey you need to put your signature on the bale stickers" ... [REDACTED] said why? I've never had to do this in 21 years... the MOF agent said it has to be done now...even though there is nowhere for a signature on stickers [see attached PDF with Affidavits from [REDACTED] and buyers];

So [REDACTED] while the bales are still in the bucket [not even on the truck to be loaded] goes and signs them all... the MOF inspector signs off/truck leaves/no problems to buyer;

Few weeks later [REDACTED] gets an offence ticket for \$61,000!!!! from the MOF agent who he complied with on site at the time first hearing about signatures;

Another man [REDACTED] . worked for years without any problems now MOF is involved he gets a \$252K fine all within a few months fall 2018 [he isn't paying it]

[REDACTED] [farmer] same deal... never had a problem until this year... hit with a \$21k fine. This is out right extortion as [REDACTED] told me [REDACTED] over the phone while stating MOF terrorize him like Gestapo and other farmers once on the property.

There are many more farmers now coming together that are willing to speak up. All are claiming abuse by these people when they come onto their property walking all over their produce damaging the product with complete disregard for the product sold;

There is no excuse for Cathy, intake or the OPP to have not acted restoring the [REDACTED] Court' and addressing the people at said PUBLIC courthouse on their actions by now;

There is no excuse for the RCMP or OPP to not have put in writing by now 2 questions [1 to Lynda Templeton and 1 to Rod Phillips MOF Minister] to address/act to correct;

Lynda's is simple.... Just put the below in writing as she must respond with the LAW;

'Produce the public law a man or woman is bound to 'rules of civil procedure';

Rod Phillips [Minister of Finance] single sentence is also simple....

'Produce 2019 license [REDACTED] held'

If no law produced... Lynda is guilty/RCMP must restore [REDACTED] court' and Lynda should be arrested. Lynda knows what she did obstructing justice against the people;

Same for Rod... one sentence requires a written response/evidence produced 2019 license [REDACTED] supposedly holds... if not produced then Rod and staff are guilty on all counts. This is why the RCMP has been contacted... actions [arrests] are warranted;

Lastly, over the past month there have been several news articles addressing this very corruption we are ALL involved in occurring by Doug Downey and Rob Ford;

This is all building on top of Brad Blair [past OPP Commissioner] press conference and court filing \$15M against Doug Ford and the service corporation called ONTARIO.

The RCMP and OPP have never been given the facts surrounding 'law' and without said facts they cannot be part of the solution which is required right now to act.

Through this one court filing and corruption all around this family it has simply been shown WHAT is to be produced immediately for their actions [trespassing]. When it is not produced immediately [as it should be easy to prove] then that is when OPP and RCMP must step in and act.

Cathy, we the people could care less about 'process at RCMP end' when it appears simple facts of right or wrong are flat out ignored... this is not acceptable Milton intake is causing further enormous wrong and harm to many others by ignoring their duties;

We require RCMP contact us and go with us to public courthouse and restore our claims that have been unlawfully removed. Seeing this process corrected will also insure our PUBLIC courthouses are NOT operating as Lynda's 'private' courthouse.

We are at 2 months and not a single act to address has occurred by RCMP or OPP.

We are going to lose our farm by March 2020 if RCMP/OPP do not act right now.

The people right across this country rely on the separation of police and judiciary to insure when FACTS of corruption are honorably brought forth ... those who took these enormous roles to protect and serve are given facts... and then act upon it with speed.

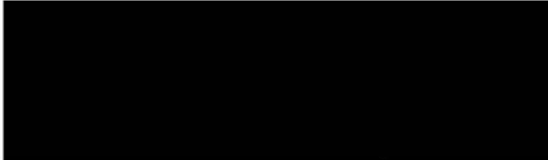
