NOTICE LIABILITY

Good Day Craig and Kelly,

Wednesday, July 17, 2024 around 3 pm two women under Craig's control and a woman under Kelly's control trespassed;

Despite our gate closed with chains these people- Jamie Wiltse and Sarah Steeves, plus the woman "Barrie" (she called herself) trespassed without right;

There was no warrant or verified claim produced we trespassed causing wrong or harm to enter our property;

- i, require [demand] the verified claim of trespass produced poste haste we have caused wrong or harm;
- i, require the contract produced with the SPCA or RCMP.

Failure to produce said required evidence then Craig or agents under his control have no jurisdiction, period; Which only leaves that Craig or Kelly or any man or woman involved make claim...

- 1. i property;
- 2. Contract exists on private side i property;
- 2. Contract exists with any service corporation [SPCA, POLICE, governments] i property;

None of this required evidence exists nor does ANY jurisdiction to trespass as these people have dishonorably;

To avoid further conflict and liability...Notice Liability is given should trespass occur again, fine is \$100,000;

Fine applies to every man or woman on private side involved who ignore and trespass on our property;

We have lived our entire lives in peace while working with animals we love and care for as our family;

We wish to live in peace with our fellow man but will not tolerate ANY man or woman who trespasses;

So you are crystal clear, it was extremely hot (over 35 C), we were resting after a long day of work started 5 am. All our animals we train/take tremendous care for over 18 years as professionals were also resting peacefully;

We own and operate a farm in Agricultural Land Reserve, part of our farming operations (god given right) is raising and training farm/sheep/protection dogs- GSDs. These are WORKING dogs and we use sheep for training;

We are breeders working with animals for decades, while Monica is a <u>certified medical professional</u> with over 40 years' experience, who took care of patients in various venues. Yet, two women under the control of Craig were insisting despite heat and our family event – a death commemoration - to see our dogs immediately.

Monica made an exception this one time allowing these women despite her emotional state to show the dogs who were resting in various kennels/yards/around or in house protected from heat exhaustion. These two women are clearly ignorant, lack education or understanding of training dogs in safe/protected environment.

They insisted to come close to our dogs, despite clear explanations that our working/protection dogs are **not** used to strangers and **DO NOT** tolerate anyone on property and neither will we moving forward.

The GSDs were barking VERY loudly, agitated, jumping around in kennels, brought to maximum distress by these two women who have no jurisdiction at all showing up on our property, who trespassed without right.

i, have taken the time to address honorably, lawfully and respectfully to insure trespass does not happen again;

If there is no verified claim or warrant with attached bond to enter our property then **Notice Liability is given**;

Of all the GSDs found on our land, almost all have been born in our hands; they are everywhere between a few months to some older -10, 12, 13 y old. Add then many others who have been adopted all over the continent.

We pride ourselves with enormous amounts of time, affection, passion and science to select, breed, raise, train and care for all these dogs along the decades, and bring them to whatever age they are now.

All healthy and beautiful...everyone who has seen them or adopted from us was truly impressed.

Govern yourselves accordingly...we do not consent/engage with people who have no jurisdiction in our lives;

Again, produce the verified claim or warrant attached with a bond to avoid trespass fine as posted and liability;
