I, Lizette Mouthon Franco, of the City of Burlington, in the Province of Ontario,

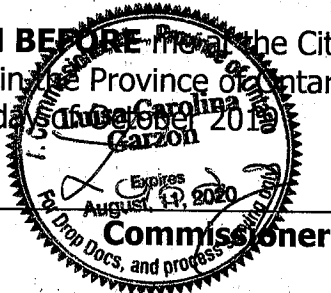
MAKE OATH AND SAY:

- 1) On September 20th, 2019 at 1:45 pm, I attempted to serve Dean Eastman: a man with the Notice: Liability, Claim: Trespass, Notice: Characteristics of

party, Notice: court; Court; COURT, Notice: Jurisdiction, Notice: Venue, and Statement of Claim, by going to 7 Queen's Park Cres, 7th Floor, Frost Building, Toronto, ON M7A 1Y7. Upon arrival, I informed the security guard of the building about my intentions to personally deliver the documents to Mr. Dean Eastman. I was told by the security guard that I was not allowed to enter the premises or deliver the documents because I did not have Mr. Dean Eastman contact information. This person then refused to provide me with a phone number I could use to reach Mr. Dean Eastman. Additionally, I was informed that due to security reasons, any document or package that is to be delivered anywhere in the building must first be checked and processed at a facility. Thus, on the same day at around 3:00 pm, I went to this location and spoke to a man who seemed to be in charge of the place but refused to identify himself. When I told him about the purpose of my visit, he refused to accept the documents because according to their regulations, documents cannot be delivered personally. Instead, they must be sent by regular mail or courier.

- 2) On September 29, 2019 around 12:17am, I served Dean Eastman: a man, with the Notice: Liability, Claim: Trespass, Notice: Characteristics of party, Notice: court; Court; COURT, Notice: Jurisdiction, Notice: Venue, and Statement of Claim by sending a copy of the documents by regular lettermail to 7 Queen's Park Cres, 7th Floor, Frost Building, Toronto, ON M7A 1Y7.
