i, was present on a November 5th 2020 conf. call set by court staff with Cindy knowledge;

Cindy stated on call 'will not be responding in writing' as required to Nov 4 2020 Notices;

Cindy stated 'do not intend to do anything differently' again ignoring Notice[s] Nov 4 2020;

Further and disturbingly on public record Cindy threatened [REDACTED] with 'consequences';

A woman acting as Justice for a service corporation is required to provide good faith services;

██████████ is under immense stress re-living the abuse she fled to protect her children;

People are NOT property to be administrated over by people acting as Hon. Justices;

Justices work for service corporations and are our most trusted public servants [employees];

Verified challenge to 'jurisdiction' is before all now a 2nd time requiring evidence produced;

Until required evidence [contracts] produced to Notice[s] November 4th 2020 and November 20th 2020 the 'Parenting and Planning Act', 'Rules of civil procedure' and 'Family Law Division' apply to ██████████. .then this current court nor Cindy has any jurisdiction [control];

Any/all presumed past or present orders are further null and void and of no force or affect;

Further, recording on Nov 5th 2020 shows Cindy acting far outside her role being neutral on said matters and further trespass against ██████████ guiding ██████████ to file 'contempt of court' and referencing Sec 40 of planning act is a nothing shy of malfeasance while acting as Justice;
