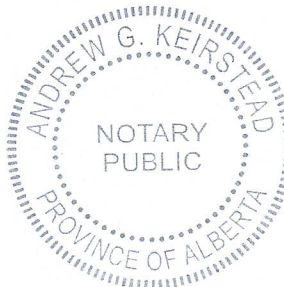

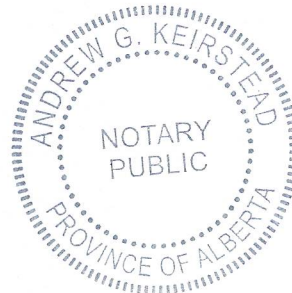

Counsel,

You have been served documents for the leave to appeal of the treason that you and your clients have participated in. The CEO has advised DSR Karis Consulting Inc.
