Statement of Claim

Claim: Trespass

[Statement of Claim]

i:Jamie James of the [REDACTED] family and i:Christopher James of the [REDACTED] family now lay claim at a 'public courthouse' invoke the common law a court of record trial by jury to seek administration of justice.
