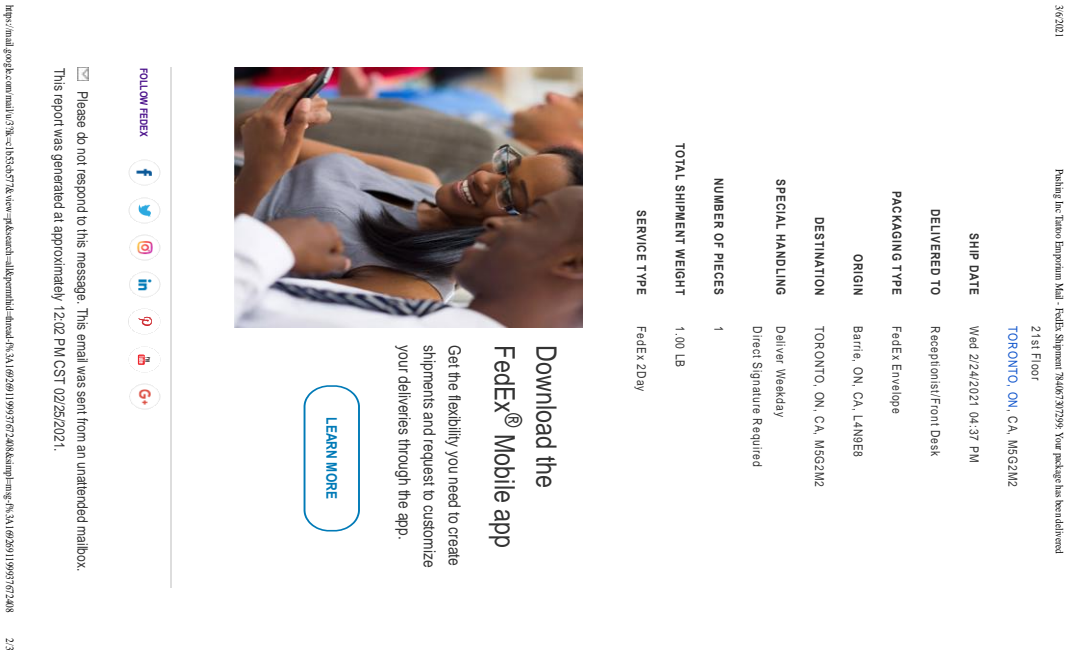

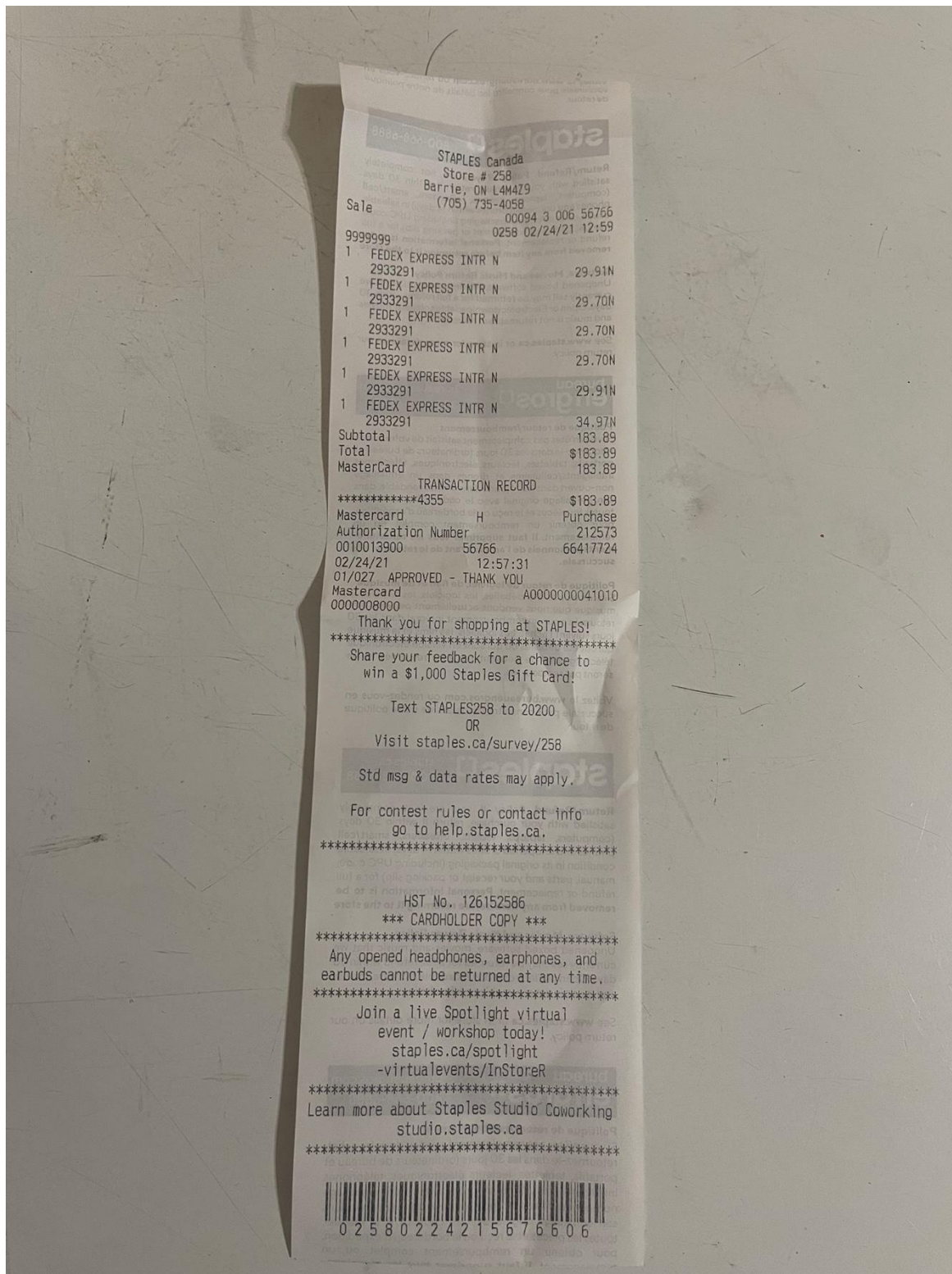



I, Antonios Makrostergios, Public Health Inspector and Program Manager for the Simcoe Muskoka District Health Unit (SMDHU), order you to take the following actions, effective immediately upon service of this order:

1. Immediately upon service of this Order close the Premises and evacuate all persons who are not directly involved with its operation or maintenance.
2. Immediately upon service of this Order post "Closed" signs at all entrances and which signs shall not be removed, covered, damaged or moved until further notice in writing from the Medical Officer of Health or a Public Health Inspector of the Simcoe Muskoka District Health Unit.
3. Immediately, comply with and adhere to Provincial business closure laws, regulations and instructions set out under the Reopening Ontario (A Flexible Response to COVID-19) Act, 2020 and the Ontario Regulation 82/20 Rules For Areas in Stage 1 which indicate that the Premises must remain closed.

REASONS FOR THIS ORDER ARE THAT:

1. On December 26, 2020, the Province of Ontario designated the Simcoe Muskoka District Health Unit as being in Stage One under the Reopening Ontario (A Flexible Response to COVID-19) Act, 2020 and Ontario Regulation 82/20 now applies to activities occurring within the Simcoe Muskoka District Health Unit; and
2. Ontario Regulation 82/20 prevents personal service settings as defined in Ontario Regulation 136/18 under the Health Protection and Promotion Act, R.S.O. 1990, c. H.7, from being permitted to open/operate; and
3. Pushing Inc. o/a Pushing Inc. Tattoo Emporium operates a business in a personal service setting;
4. Benjamin James Anthony Russo is the Director and directing mind of Pushing Inc.
5. On February 11, 2021, the Program Manager with the Simcoe Muskoka District Health Unit, witnessed the premises open for business which was in contravention of Ontario Regulation 82/20; and
6. COVID-19, a novel coronavirus, is designated as a disease of public health significance and a communicable disease pursuant to the Health Protection and Promotion Act, 1990, R.S.O., c. H.7, which poses a serious risk to the health of others in the Simcoe Muskoka District Health Unit; and
7. COVID-19 is present in Simcoe Muskoka District Health Unit and therefore poses a risk to the health of the residents of Simcoe Muskoka through community transmission.
8. The COVID-19 virus is spread from an infected person to an uninfected person by direct contact or from a close encounter where respiratory secretions from the infected person are transmitted to the uninfected person; and
9. That COVID-19 may be transmitted from one person to another during an asymptomatic and pre-symptomatic state; and
10. Failure to comply with the provincial requirements outlined in the Reopening Ontario (A Flexible Response to COVID-19) Act, 2020 for personal service settings poses an immediate health hazard with the increased risk of an outbreak, worsening an existing outbreak and/or add further outbreaks in the Simcoe Muskoka District Health Unit.
11. The additional resources required of the local health care system when an outbreak occurs poses a serious health hazard to the residents and visitors of the Simcoe Muskoka District Health Unit.

As a result I am of the opinion, based on reasonable and probable grounds, that:

1. A health hazards exists in the health unit served by me; and
2. The requirements specified in this Order are necessary in order to decrease the effect of or eliminate the health hazard.

****DECISION****

Re: Our Request Number: MAG-A-2021-00611

This is in response to your request under the Freedom of Information and Protection of Privacy Act (the Act) for access to:

"Any records in the possession, custody or control of Doug Downey or the office of the Attorney General that:

1. prove or evidence (via ownership, contract or consent) that the "rules of civil procedure" (that were promulgated by a private society/corporation) apply to, or, have jurisdiction over, i, Christine Anne of the Massey family (a flesh and blood woman), or to any man, woman or child (versus "persons"/corporations); and/or
2. prove or evidence (via ownership, contract or consent) that any man or woman has the right to block or prevent i, Christine Anne of the Massey family (a flesh and blood woman), or any other man or woman, from accessing a public courthouse to seek the administration of justice and move claim and court, (as clarified on December 31, 2021)."

Please be advised a search for records was conducted and no responsive records were located. Parts 1 and 2 of the request are not framed as a request for information but instead ask the Ministry to address a legal argument concerning jurisdiction of the Rules of Civil Procedure and access to the courts with respect to "a flesh and blood woman". In effect, the request asks the Ministry to justify the rule of law and the Ministry is not able to give legal advice.
