Clearly there seems to be a lack of communication between Jackie Foley and administration at courthouse;
i:woman:Susan of the [REDACTED] family did address and settle this further administration error prior to 15-days;
i... communicated with Jackie June 28th 2022 and no required evidence [contract or verified claim] see notices;
i...returned offer contract [offence ticket] and did/do not consent requiring court administration records corrected;
1st Notice sent by email on June 28th, 2022. 2nd sent on July 4th, 2022, 3rd sent on July 6th, 2022;
Final Tacit Agreement sent on July 8th, 2022. Couriered July 10th, 2022. [which i attach all again]
i...received letter claiming a debt be due once again without right dated August 10, 2022 [exhibit 2];
Who is man/woman acting as justice of the peace making a judgement? i...require this is given to them post haste;
Further i as every man and woman hold the right to enter Canada as on page 2 of passport. i will quote:

“The Minister of Foreign Affairs of Canada requests in the name of Her Majesty the Queen, all those whom it may concern to allow the bearer to pass freely, without delay or hindrance, and to afford the bearer such assistance and protection as may be necessary.”
